**Circular Five: To All Known Creditors and Other Affected Persons of Forest Hill City Shopping Centre Proprietary Limited (Registration Number:2007/004487/07) (In Business Rescue) (the “Company”)**

23 January 2023

1. On 19 January 2023, the appointed joint business rescue practitioners (“BRPs”) of the Company issued a circular in the business rescue proceedings of the Company, wherein a consent was sought from creditors to extend the due date for the publication of the business rescue plan from 20 January 2023 to 17 February 2023.
2. The majority of the creditors’ voting interests (exercising their votes) voted in favour of the extension of the due date for the publication of the Company’s business rescue plan to 17 February 2023.
3. The voting interests exercised for the extension of the date for the publication of a business rescue plan was as follows:
  - 3.1. None of the creditors voted against the extension.
  - 3.2. One creditor voted in favour of extension. The total value of claim for the creditor amounts to R7 466 849 492,37.
4. Accordingly, it is recorded that the due date for the publication of the business rescue plan has been extended to 17 February 2023
